

Change to Class Fees for Working Members



As announced at the May general meeting, there is a change to class fees paid by Club working members. Starting with the next session beginning on July 10⁻ 2025, the working member fee reduction will be \$30 for an 8-week class session. Members will pay a reduced fee amount of \$90 per session. The reduction for Board members remains at \$50 per session. This change applies to both training locations in Watsonville and Capitola.
